Major in Textile, Graduate on Garment Technology, University Graduate etc.


#### 2. Working experience

**Fabric** 

Knitted and Woven Fabric, Plies and Rolls, Stripes, Solid, Grey and Yarn Dyed

Garments

Dress, Jackets, Inner Ware (Under Garments), Shirts, Trousers, Sweater, Leather clothes made by Fabric and Leather material

**Foot Wear** 

Shoes, Slippers, Boots, Sandals usually fit for people living, walking and working.

Home Textile

Any product used for House Decoration, Towels, Curtains, Bed sheets, Bath robes, Bath mats, Rugs and other categories.

Accessory

Socks, Caps and other fashion articles

## **Inspection Service Types**



- 1. Final Random Inspection-FRI (100% produced and minimum 80% packed).
- 2. Initial Production Inspection-IPI (10-20% of total quantity produced).
- 3. During Production Inspection-DPI (40-60% of total quantity produced).
- 4. Fabric Inspections (4- Point System & 10-Point System).
- 5. Re-Inspection / Re-FRI (Once FRI got failed due to any reason).
- 6. Loading / Unloading Supervision.
- 7. 100% Inspections(100% of total order/produced quantity).
- 8. Sample Picking/Sample Collection for Lab Testing.
- 9. Compliance Audits.
- 10. Capacity Building of Factory or Buying Office QC Team.

#### **Final Random Inspection Scope**



#### Standard Inspection Criteria:

- Sampling Plan: Single
- Inspection Procedure: Normal
- Inspection Level: Level II
- AQL Criteria: Critical 0 / Major 2.5 / Minor 4.0
- Measurement Criteria: 10 % allow out of tolerance of total measured points or for some Clients 3Pieces/Size covering all colors and sizes as per Client requirements.
- Square Root of Total # of Cartons (round the number up).

#### Standard Inspection Scope:

- Export Carton Condition
- Product Packaging Condition
- Barcode Verification & Metal Detection
- Product Inspection Workmanship, Feel, Color Shading, Labeling,
- Product Inspection Functional like Zipper Verification
- Product Weight and Measurement


